



## **Global LGBTQ+Allies Scholarships Terms and Conditions**

### **Global LGBTQ+Allies Scholarship**

De Montfort University are pleased to announce two new international postgraduate taught scholarships offering for September 2019 study.

Our Full Postgraduate Scholarships which will cover the total value of the course fee; will be awarded to two outstanding students domiciled outside of the UK and European Union. The students are to demonstrate passion to advocating for LGBTQ+ rights and commit to helping DMU become a safer space for their LGBTQ+ population. The students are to have excelled academically, completed an application statement and must have an offer of admission to any one of our eligible one year full-time postgraduate taught programmes. Award of these scholarships are through an application and selection process.

The scholarships also include an additional £1015 (excluding any taxes) per month for the duration of the course, to assist with accommodation and living costs. The closing date for these scholarships is midnight 26<sup>th</sup> July 2019 for the September 2019 intake.

### **Minimum entry requirements**

An offer of admission from De Montfort University for a full time, post-graduate taught course starting September 2019.

Successful completion of any English Language requirements tests.

Domiciled outside the UK, European Union or Schengen Area.

### **Scholarship requirements**

In order to be awarded the scholarship, you must be willing to fulfil some of the following duties whilst studying:

- Assist with the organisation of relevant DMUPride events and help DMU organise initiatives for national/international LGBTQ+ awareness days.
- Become an active member of the DMU LGBT Society.
- Act as a student champion for current and potential international students and applicants who wish to discuss LGBTQ+ concerns.
- Continuing activism after successful completion of study.



### **Application process**

To apply, please complete the scholarship application web form.

### **Closing date**

All application should be submitted by midnight 26<sup>th</sup> July 2019 for September 2019 study.

Successful recipients of the scholarship will be notified in writing during the week commencing 19<sup>th</sup> August 2018. Please ensure that you have received an offer of admission before applying for this scholarship.

### **Terms and conditions**

- This scholarship is only available to students domiciled outside the UK, European Union or Schengen Area.
- Applications must be made through the online scholarships web form by midnight of the published closing date. Applications received after this deadline will not be considered.
- The student awarded the scholarship will be notified in writing. The award of this scholarship is at the discretion of the selection panel.
- An offer of admission must be received in order to be eligible to apply for this scholarship.
- The scholarship is valid only for entry into the September 2019 intake – scholarships cannot be deferred by the applicant.
- The students receiving this scholarship will not be eligible for any additional scholarships or discounts. If a student is also eligible for another scholarship, he or she will only receive the higher value scholarship.
- The scholarship also includes an additional £1015 stipend per month, which will be used towards accommodation and living costs.
- Applicants who have already completed a postgraduate taught course with DMU will not be eligible for this scholarship.
- Distance learning and part time students are not eligible for this scholarship.
- No cash alternatives will be offered and the scholarship cannot be transferred to another recipient.
- Only fully self-funded students are entitled to apply for this scholarship.
- The scholarship will be forfeited if the student defers entry, withdraws his or her application or does not enrol. If a student is found to be in breach of the student regulations the university is entitled to immediately suspend a scholarship.
- This scholarship is awarded at the discretion of the University.
- De Montfort University (DMU) reserves the right to review, review or withdraw the scholarship up to the point of enrolment if the applied for course is no longer run. The student will be informed in advance of this decision at the earliest opportunity.
- Where a student terminates or interrupts their studies, prior to the completion of their course, both the tuition fees and the scholarship will be apportioned pro-rata, based



on the student's last date of attendance.

- Applicants must have no outstanding debt to the university prior to receiving the award.
- Any scholarship payment made by DMU in error or paid as a result of false information submitted by the student will be recovered repayable by the student.
