



### NOTICE No. 80/2022 - PROE/UEMS, OF JULY 5, 2022

#### SELECTIVE PROCESS FOR ADMISSION TO UNDERGRADUATE COURSES FOR REFUGEES, MIGRANTS IN SITUATION OF VULNERABILITY AND STATELESS PERSONS

The Dean of Education of the State University of Mato Grosso do Sul (UEMS), in the use of its attributions, and in accordance with the Resolution CE/CEPE-UEMS n<sup>o</sup> 2.327, of August 4, 2021, makes public the Opening of the Applications for the **SELECTIVE PROCESS FOR ADMISSION TO UNDERGRADUATE COURSES FOR REFUGEES, MIGRANTS IN SITUATION OF VULNERABILITY AND STATELESS PEOPLE**, with a view to selecting candidates to fill the remaining vacancies in the undergraduate courses at the State University of Mato Grosso do Sul, with admission in the 2nd semester of 2022 for semester courses and, in the 1st semester of 2023 for annual courses, subject to the conditions established in this Notice and other legal provisions.

### 1. PRELIMINARY PROVISIONS

1.1. The Selection Process for Admission to Undergraduate Courses for Refugees, Vulnerable Migrants and Stateless Persons, object of this Notice, will be carried out by the Student Admission Division (DIND) and decisions on the merits on the acts and facts involving the event will be supervised by the Dean of Education (PROE).

1.2. According to the Resolution CE/CEPE-UEMS No. 2,327, of August 4, 2021, it is understood as:

a) **A refugee**, a person who "with good reason for fear of being persecuted on account of his race, religion, nationality, membership of a certain social group or political opinions, is outside the country of his nationality and is unable or, owing to fear, does not want to ask for the protection of that country" (Convention on the Status of Refugees, Art. 1 - A, no. 2, of 1951, as amended by the 1967 Protocol).

b) **Migrants in situations of vulnerability** those with limited capacity to avoid, resist, deal with or recover from the potential risk or situation of violence, exploitation and abuse to which they are exposed or that they experience in the migratory context.

c) **A stateless** person, the one not considered by any State, according to its legislation, as its national (Article 1 of the United Nations (UN) Convention on the Status of Stateless Persons of 1954).

Single paragraph. For the purposes of this Deliberation, Brazilian citizens, even binational, as well as those whose father or mother is Brazilian will not be considered as refugees, vulnerable migrants and stateless persons.

1.3. In accordance with the Resolution CE/CEPE-UEMS No. 2,327, of August 4, 2021, persons in the condition of refugees, migrants in situation of vulnerability and stateless persons are those who prove:





I - the situation of refuge, migration in situation of vulnerability or stateless person, in accordance with current legislation;

II - the completion of High School in Brazil or equivalent carried out abroad, recognized by the State Board of Education;

1.3.1. For candidates who qualify for admission as holders of a diploma, after being called and enrolled, they must request the use of studies in the coordination of the course, following the current regulations of the Institution.

1.4. The Selection Process will consist of the following phases:

I – Enrollment through the procedure described in item 3;

II - Analysis and scoring of the Languages and Mathematics grades of the high school transcript or equivalent, of the candidate.

1.5. The effective registration of the candidate implies knowledge and tacit acceptance of the rules and conditions established in this Public Notice, about which no claim of ignorance can be claimed.

1.6. No application fee will be charged from the candidate for the vacancies offered by UEMS.

1.7. Candidates will be invited to enroll exclusively in the courses listed in Annex I, according to the classification and number of vacancies.

# 1.8. The times mentioned in this Notice are the official ones of the State of Mato Grosso do Sul.

# 1.9. Information regarding this Notice and other updates will be available on the UEMS Portal, at http://www.uems.br/ingresso/formas.

1.10. The results of this Selection Process will be valid for admission in the 2nd semester of the 2022 academic year, for semester courses, and in the 2023 academic year for annual courses, within the limit of available places in the courses.

1.11. Included in the Annexes to this Notice:a) ANNEX I - COURSES WITH REMAINING SPOTS;b) ANNEX II - TABLE OF EQUIVALENCE BETWEEN CONCEPTS AND NOTES;c) ANNEX III - APPEAL FORM.

### 3. REGISTRATION

3.1. Registration will be made exclusively through the Internet, between 8:00 am on July 06, 2022, and 11:59 pm on July 20, 2022 (official time in Mato Grosso do Sul).

3.2. To register, the candidate must fill in the Registration Form available at **https://forms.gle/Fa3upxgFk2fwU4U6A** or by QR CODE, informing their personal data, per capita income, course in which they are interested, and the Language and **Mathematics grades included in the High School Transcript (or equivalent course) or in the High School Certification issued by the certifying institutions.** 

3.3. The candidate may enroll in only one course, and must review and submit the Enrollment Form, taking responsibility for the accuracy of the information contained therein.

# **3.4.** The candidate is fully responsible for the veracity of the data provided when filling in the Application Form.

3.5. At the end of filling, for confirmation of registration, when sending the form, the message "Your answer has been registered" will be issued.





3.6. The candidate will only be considered enrolled in the Selection Process after having complied with all the instructions provided for in this Notice and having his data included in the Notice with the List of Approved Enrollments.

3.7. In case the registration is not carried out, the candidate must contact the Reception Sector/PROEC, via the email atendimento@uems.br, to verify what happened.

### 4. APPEALS

4.1. The candidate may appeal regarding the Disclosure of the List of Approved Applications from 8:00 am on July 22 to 11:59 pm on July 25, 2022, by sending the Appeal Form to the email dind@uems.br.

4.1.1. The candidate may submit an appeal to the List of Approved Applications, and may address errors and/or data inconsistency, as per item 2 of this Notice, by e-mail to dind@uems.br.

4.1.2. The candidate can only send the Appeal Form (ANNEX III - APPEAL FORM) only once, and it is not possible to enter new information after submission.

4.1.3. The appeals must contain justification and a scanned copy of documents for proof, under penalty of not knowing.

4.1.4. The Appeal Form and scanned copy(s) of document(s) must be in a single file and in Portable Document Format (PDF).

4.2. Appeals that do not comply with the form (Appeal Form) and deadline (period and time), as set out in item 2 and in ANNEX III - APPEAL FORM of this Public Notice will be rejected.

4.3. Appeals filed in person, by post, fax and/or any other means will not be accepted.

4.4. Under no circumstances may the decision that considers the appeal be appealed.

### 5. CLASSIFICATION

5.1 The classification of candidates will be organized in descending order, based on the calculation of the Candidate's General Average (MGC), based on the arithmetic average of the Language and Mathematics Grades that correspond, respectively, to the Areas of Languages, Codes and its Technologies and Mathematics and its Technologies, with up to two decimal places separated by point, considering the data contained in the High School Transcript (or equivalent course) or in the High School Certification issued by the certifying institutions, indicated by the candidate on the





Application Form for this Selection Process.

5.2. In the case of using the Academic Transcript, with the identification of grades for each of the series studied during High School (or equivalent course), for the calculation of the Language and Mathematics Grades that correspond, respectively, to the Areas of Languages, Codes and its Technologies (NLCT) and Mathematics and its Technologies (NMT), consider the following formulas:

$$NLCT = \frac{(N \, 1 \, SLP) + (N \, 2 \, SLP) + (N \, 3 \, SLF}{3}$$

$$NMT = \frac{(N1SM) + (N2SM) + (N3SM)}{3}$$

Description:

NLCT - Language Note that corresponds to the Area of Languages, Codes and their Technologies,

N1SLP - Grade referring to the 1st Grade of High School in the Languages subject, N2SLP - Grade referring to the 2nd Grade of High School in the Languages subject, N3SLP - Grade referring to the 3rd Grade of High School in the Languages subject,

NMT - Mathematics Grade corresponding to the Area of Mathematics and its Technologies (Mathematics),

N1SM - Grade referring to the 1st Grade of High School in Mathematics,

N2SM - Grade referring to the 2nd Grade of High School in Mathematics,

N3SM - Grade referring to the 3rd Grade of High School in the Mathematics subject.

5.3. In the case of using the High School Transcript (or equivalent course) issued from the adoption of an evaluation system on a numerical scale different from 0 (zero) to 10 (ten) points, for the indication of Language and Mathematics that correspond, respectively, to the Areas of Languages, Codes and their Technologies and of Mathematics and their Technologies, the educational institution must inform the equivalence between the two scales and the information can be given in the document of proof of schooling, presented by the candidate or in a letter to be presented at the time of registration.

5.3.1. In the event that the educational institution does not inform the correspondence between the scales, the numerical grades recorded in the schooling document must have their values converted, by the candidate (Annex III), proportionally to the scale from 0 (zero) to 10 (ten), considering the maximum value of the scale adopted by the educational institution as corresponding to grade 10 (ten).

5.4. In the case of using the High School Transcript (or equivalent course) with grades recorded in the form of Concepts, without information on the corresponding numerical values, for the indication of the Language and Mathematics Grades that





correspond, respectively, to the Language Areas, Codes and their Technologies and Mathematics and its Technologies, the candidate must consider the equivalence between the Concepts and Grades converted to a scale of 0 (zero) to 10 (ten) points, according to ANNEX III - TABLE OF EQUIVALENCE BETWEEN CONCEPTS AND NOTES of this Public Notice.

5.5. In the event of a tie, the tie will be broken considering the criteria in the following order:

I. Highest Score obtained in Languages corresponding to the Area of Languages, Codes and their Technologies;

II. Highest Grade obtained in Mathematics corresponding to the Mathematics Area and its Technologies;

III. Older age.

### 6. RELEASE OF RESULTS

6.1. The List of the Final Result of the Selection Process will be published on July 27 in the Public Notice, through the electronic address http://www.uems.br/ingresso/formas.

6.2. The Final Result List will contain the candidate's data according to the information filled in the Application Form, such as: University Campus, Course, Shift, Full Name, Identification Document, Classification and General Average of the Candidate.

### 7. ENROLLMENT

7.1. The Call for Enrollment Notice will be published on July 28 through the electronic address http://www.uems.br/ingresso/formas.

7.2. At the time of registration, the following documents must be presented for verification by the Selection Process Committee:

I – For Refugees: Documentation proving refugee status, issued by CONARE, for the applicant in refugee status;

II – For Asylum Seekers: Asylum request protocol issued by the Federal Police;

III - For migrants receiving Humanitarian Reception: National Migration Registration Card or Provisional Document of National Migratory Registration (DPRNM);

IV – For migrants who do not qualify for Humanitarian Reception: National Migration Registration Card or Provisional Document of National Migratory Registration (DPRNM);

V - Proof of equivalent studies for admission to Higher or Technical Education;

### 8. GENERAL PROVISIONS

8.1. In case of impediment to the enrollment due to difference in grade, at the time of checking the supporting documentation, the candidate will be reclassified on the





waiting list and will be summoned, if there are vacancies after the summons of all the classified candidates, following the order of reclassification, in order to take advantage of their registration for this Selection Process.

8.2. The refugee candidate, migrant in situation of vulnerability and stateless person will be regularly enrolled in accordance with the rules that govern undergraduate courses at UEMS, and will be subject to the same academic standards applicable to Brazilian students of the Institution and Brazilian laws.

8.2.1. The refugee candidate, migrant in situation of vulnerability and stateless person will be able to apply for the notices of scholarships and other permanence programs, after the effective registration, in accordance with the rules of UEMS.

8.3. A refugee student, an migrant in situation of vulnerability and a stateless person who, in a proven way, has used false documents and/or information and/or any other illegal means, or even, at any time, loses his regular stay in Brazil will be terminated from the course.

8.4. Any questions and supplementary information may be answered by the Reception Sector, by electronic means at the email atendimento@uems.br.

8.5. Omitted cases are resolved by the Dean of Education (PROE), after hearing the Sector for Reception for Refugees, Migrants in situation of vulnerability and Stateless Persons of UEMS.
